SUPERINTENDENT COMMENTS

Mrs. DuBois gave an update on the Lilly Endowment grant process. The application is due on May 19. Results will be announced in September.

Mrs. DuBois shared the middle school will be piloting a PLTW course - Introduction to Engineering and Design in the 2017-2018 school year.

Mr. Harpe shared back to school dates for the 2017-2018 school year.

Mr. Manns said the first class of the Seymour High School Athletic Hall of Fame inductees have been selected. They will be introduced at a Boys Basketball game this winter.

Mr. Brown and Mrs. Bohle introduced Mrs. Tammy Marksberry. She was recently awarded the Indiana Association of School Principals Secretary of the Year for going above and beyond for the families of Jackson Elementary.

ACTION ITEMS

Mr. Nauman made a recommendation to approve the 2017-2018 K-8 textbook rentals. K-5 will see a slight increase, but 6-8 rates will decrease by \$10. Mrs. Franke moved and Mr. Klosterman seconded. Motion carried; 6-0.

Mr. Nauman presented information for Corporation picture bids. He received two bids for a three year deal with Inter-state Studio and Lifetouch for school picture services. He made a recommendation to use Lifetouch due to lower prices for parents. Mr. Silver motioned to approve and Mrs. Franke seconded. Motion carried; 6-0.

Mr. Fosbrink made a recommendation to approve the fuel specifications and seek bids for the 2017-2018 school year. Mr. Klosterman moved and Mr. Browning seconded. Motion carried; 6-0.

Mr. Prange made a recommendation to add Advanced English/Language Arts to the curriculum at Seymour High School for the 2017-2018 school year. Mr. Silver moved and Mr. Kelley seconded. Motion carried; 6-0.

Mr. Stark made a recommendation to approve an agreement between the school corporation and WorkOne JAG program. This will allow JAG students to work up to 40 hours a week with the custodial staff throughout the summer. WorkOne will pay the student's salaries. Mrs. Franke motioned to waive first read and Mr. Browning seconded. Motion carried; 6-0. Mrs. Franke then motioned to approve the agreement and Mr. Browning seconded. Motion carried; 6-0.

Mr. Stark made a recommendation to accept the quote from Carpet Gallery to continue on the summer replacement rotation in the schools. \$126,953.69 will be taken out of CPF building acquisition funds. Mr. Klosterman motioned to approve the work and Mr. Silver seconded. Motion carried; 6-0.

Mrs. Altemeyer requested permission to apply for \$20,000 for the 2017-2018 Safe Haven grant. These funds help pay for one of the corporation's three school resource officers. Mr. Browning moved and Mr. Kelley seconded. Motion carried; 6-0.

Mrs. Ferguson made a recommendation to adopt Math and Science books for advance placement courses. Mr. Browning moved and Mrs. Franke seconded. Motion carried; 6-0.

NEW BUSINESS - FIRST READ ITEMS

Mr. Nauman reported there will be no changes at this time for the 2017-2018 classified employee handbook except for the date and a few grammatical revisions. He will recommend no change to the salary schedule for the upcoming year.

Mr. Stark requested permission to seek corporation lawn mower bids. Mr. Klosterman asked that we ask for a variety of types of mowers. For example, what would the price difference be between diesel and gasoline? Mr. Silver suggested he look into different tire options as there is an advertised "no flat tire" available to consumers. Mr. Stark will return in June with quotes.

Mr. Nauman discussed the 2018 Budget.
