Members of the Board of School Trustees met in executive session at 6:00 p.m. on this date at the Central Office pursuant to Indiana's Open Meetings Law for the purpose of discussion of strategy with respect to: Collective Bargaining, Initiation of litigation or litigation that is either pending or has been threatened specifically in writing; and discussion of the assessment, design, and any individual over whom the governing body has jurisdiction: to discuss, before a determination, the individual's status as an employee, a student, or an independent contractor. Mr. Nauman made a recommendation to adopt the additional appropriation resolution of \$500,000 to General Fund - Personnel Services. Mr. Silver moved and Mr. Browning seconded. Motion carried; 6-0.

Mrs. Franke motioned to adjourn the Appropriation Hearing and Mr. Silver seconded. Meeting was adjourned at 7:01 p.m.

Mr. Nauman reported the corporation received \$3,293.40 from the auction.

Mr. Nauman said six bids were received for the 2018 General Obligation bond sale. Jackson County Bank was the winning bidder and provided a1.413% interest rate. The bond closing is scheduled for December 5, 2017.

Mr. Hooker introduced Mr. George Link from VPS Architecture to discuss the SHS Science classroom designs.

Mrs. Cheryl Fenton announced it was American Education Week.

Mr. Prange shared the JAG convocation was very well received by students and staff. Another presentation will be open to the public on Friday, November 17 at 6:30 p.m.

Mr. Prange informed that 130 high schools out of the 434 in the state of Indiana were recognized for dual credit involvement. He announced Seymour High School was one of ten high schools that received Silver status.

Mr. Prange handed out pencils with the boys and girls basketball schedules on them.

Mr. Stark made a recommendation to approve the replacement of bleacher boards by BR Bleachers for \$5,510 at Seymour High School. Mr. Browning motioned to approve and Mr. Joray seconded. Motion carried; 6-0.

Mr. Stark made a recommendation purchase an automatic scrubber. Mr. Joray questioned if this was was an emergency and a first read. He also asked for another quote. The item was tabled to next meeting.

Mrs. Dubois made a recommendation to approve Community Service and Entreprenuership and New Ventures capstone to the high school's approved course list. Mr. Joray moved and Mr. Silver seconded. Motion carried; 6-0.

Mr. Hooker made a recommendation to to approve the agreement with Southern Indiana Sports Mall, Inc. to use their facility and equipment for gymnastics. Mr. Joray questioned if this was a first read. Mr. Silver moved to waive first read and Mr. Browning seconded. Motion carried; 6-0. Mr. Browning motioned to approve the agreement and Mr. Silver seconded. Motion carried; 6-0.

Mr. Harpe annouced the corporation was awarded the \$50,000 Secured School Safety grant. The \$50,000 corporation match will be paid from Capital Projects Fund. Mr. Silver moved and Mrs. Franke seconded. Motion carried; 6-0.

Mr. Fosbrink made a recommendation to seek bids for an equipment van, 2 buses with wheelchair lift, 2 transit buses, and 1 mini bus. Mr. Silver motioned to approve and Mrs. Franke seconded. Motion carried; 6-0.

Mr. Nauman requested permission to seek quotes for development of school insurance package specifications. Once that is complete, they would like seek quotes for insurance packages including commercial auto, commercial package, umbrella policy, and workers compensation.

Mrs. Lister reported Cortland has approximately \$70,000 left from the Library addition. She requested permission to seek quotes for new cabinetry in all six classrooms. She will return with the information in December.
