COMMUNICATIONS & REPORTS

SUPERINTENDENT COMMENTS:

Mr. Prange thanked all those who helped make Graduation a success. 311 Seniors were eligible to participate in the ceremony this year; 270 students walked. Twenty-one students are working this summer to complete the requirements with five students finishing this week. Mr. Prange added that the students must be finished to walk in the ceremony.

Mrs. DuBois presented information on programming at the high school. This included Owl Manufacturing, Agriculture programs, Junior Main Street, the partnership with ABC Construction and the Work Based Learning program.

Mrs. Purkhiser thanked the Board for the opportunity to offer Archery at Seymour High School. They just finished their third year competing. This year will be the first year offering a Summer Archery Owls camp. Mr. Juergens expressed his appreciation and thanked her and the archery coaching staff for offering the students of Seymour High School this opportunity.

Mrs. Ahlbrand provided the board with a copy of the 2017-2018 Seclusion/Restraint report.

Mr. Harpe announced 17 elementary students were enrolled in RoBoCode Camp that will begin next week. The middle school camp will host 46 students.

Mr. Stark gave an update on the summer projects taking place throughout the corporation.

Mr. Stark made a recommendation to approve the installation of standing wall panels at Seymour Middle School. This is a continuation of the project started by Royalty Companies. Mrs. Franke motioned to approve and Mr. Silver seconded. Mr. Kelley asked that we bid out the project again and Mr. Joray agreed. Motion failed; 0-7.

Mr. Stark made a recommendation to accepts quote and award work to Turnkey Mechanical to replace a failed boiler at Seymour High School for \$\$59,916. Mr. Klosterman moved and Mr. Silver seconded. Motion carried; 7-0.

Mr. Stark made a recommendation to accept quotes and award work to replace a water main water line valve at Seymour High School. Mrs. Franke moved and Mr. Browning seconded. Motion carried; 7-0.

Mr. Manns made a recommendation to approve the 2018-2019 Student Athlete-Parent Handbook. The only change is to follow the ejection policy used for coaches and athletes for any adult ejected from an event. Mr. Klosterman moved and Mrs. Franke seconded. Motion carried; 7-0.

Mr. Harpe requested permission to publish parent teacher conference dates for the 2018-2019 school year. Mrs. Franke motioned to approve and Mr. Joray seconded. Motion carried; 7-0.

Mr. Fosbrink presented the Transportation handbook. At this time he does not plan to change anything unless directed to do so by new state legislation.

Mr. Manns provided three quotes for the replacement of the high school basketball scoreboards. It is his recommendation to go with NevCo as they were the only company able to duplicate the current size.
