#### SCHOOL BOARD MINUTES **APRIL 9, 2019**

Members of the Board of School Trustees met in executive session at 5:30 p.m. on this date at the Central Office pursuant to Indiana's Open Meetings Law for the purpose of discussion of strategy with respect to any of the following: Initiation of litigation or litigation that is either pending or has been threatened specifically in writing, and with respect to any individual over whom the governing body has jurisdiction: to discuss, before a determination, the individual's status as an employee, a student, or an independent contractor. No topics were discussed other than those listed on the public meeting notice. All members were present.

President Juergens called the 2019 Bond Issue Additional Appropriation Hearing to order at 7:10 p.m. All members were present.

Mr. Nauman stated the Board was ready to hear all taxpayers desiring to be heard in respect to the matter of the additional appropriation in the amount of \$5,170,000. There were none.

Mr. Browning motioned to approve the recommendation to adopt the additional appropriation resolution, the Final Bond Resolution approval of form of continuing disclosure undertaking, the appointment of a bid committee, and a recommendation to adopt resolution approving amended and restated post-issuance compliance procedures. Mrs. Franke seconded. Motion carried: 7-0.

Mr. Klosterman moved and Mr. Joray seconded a motion to adjourn. The 2019 Bond Issue Additional Appropriation Hearing was adjourned at 7:15 p.m.

President Juergens called the Regular Board meeting to order at 7:15 p.m. All members were present.

Board members and members of the public stood for the Pledge of Allegiance and a Moment of Silence.

Mr. Harpe made a recommendation to approve the agenda as presented. Mr. Joray moved and Mrs. Franke seconded. Motion carried; 7-0.

Mr. Browning moved and Mrs. Franke seconded a motion approving the consent agenda which included the minutes of the March 12, 2019 regular meeting, monthly reconciliation summary, claims and payroll, fund report, monthly appropriation report, student enrollment update, personnel recommendations, professional leave requests, and SHS Volleyball Overnight Trip to Purdue University Team Camp.

Mrs. Franke made a recommendation to approve the Board's vision statement of "Soaring to Excellence; Every One Every Day." Mr. Browning moved and Mr. Klosterman seconded. Motion carried; 7-0.

Mrs. Townsend made a recommendation for C & T Design and Equipment Company of Indianapolis to replace the Emerson Serving Line for \$14,877. Mrs. Franke moved and Mr. Kelley seconded. Motion carried; 7-0.

Mr. Nauman made a recommendation to approve the 2019-2020 Elementary and Middle School book rental rates. There are no changes at the middle school. Mr. Joray moved and Mr. Tormoehlen seconded. Motion carried; 7-0.

Mr. Stark made a recommendation to purchase an electronic marquee for Jackson Elementary. Two quotes were received. The board requested additional information before they vote. Mr. Stark will return in May.

Mr. Stark received two quotes for summer carpet installation. He made a recommendation for Carpet Gallery to complete work at Administration Building, Jackson, Seymour Middle School, Redding Hall Phase II, and Redding Library Office for \$107,820.05 and Floors Unique to complete the work at Brown and Special Education Hallway for \$26,200. Mrs. Franke moved and Mr. Klosterman seconded. Motion carried; 7-0.

Mr. Stark made a recommendation to complete interior painting and renovations at Seymour Middle School, Seymour High School, Redding and Brown. Mr. Klosterman moved and Mr. Tormoehlen seconded. Motion carried; 7-0.

Mr. Stark made a recommendation to approve exterior yellow paint work to S& B Wallcoverings at Cortland, Emerson, Jackson, 6<sup>th</sup> Grade Center, Administration Building, and Seymour High School for \$2,495 and Long Striping for Brown, Redding, and Seymour Middle School for \$2,000. Mr. Joray moved and Mr. Kelley seconded. Motion carried; 7-0.

Mr. Stark made a recommendation to replace and repair the complete EFIS system on the Auxiliary Gym to strengthen and extend the life of the system, weather proof the existing panels, repair the damaged areas, and give a more uniform appearance. Mr. Klosterman motioned to waive the first read and Mrs. Franke seconded. Motion carried; 7-0. Mrs. Franke then motioned to approve the work and Mr. Tormoehlen seconded. Motion carried; 7-0.

### **NEW BUSINESS - FIRST READ ITEMS**

Mr. Stark reported the high school weight room is in need of an air conditioning/dehumidification system to dry out the room to protect the new weight room equipment. He is working with the architect to develop specifications for the project.

Mr. Nauman reported that the Toshiba copier lease is up for renewal. Toshiba is currently offering to buy out the remainder of the current lease and replace 35 copiers. Staff will be required to complete training on the copiers prior to using the new machines as they will have more secure features that will help cut down on the paper waste. Mr. Joray requested it be put up for bids even though Toshiba is a state bid. In order to get the new copies installed over the summer, Mr. Kelley motioned to waive the first read and Mrs. Franke seconded. Motion carried; 7-0. Mrs. Franke motioned to approve the lease renewal and Mr. Browning seconded. Motion carried; 7-0.
